Restoration Church Glow in the Dark Egg Hunt Rules:

General Rules:

- Each participant must have a liability waiver submitted to the registration desk and should have on their participant armband (including adults) always.
- No running in the facility.
- Parents please watch your kids to make sure they are following the rules.
- Restoration Church is not responsible for any lost or stolen items.

Blow Up Rules:

- No flips, summersaults or any kind of gymnastic maneuvers on the inflatables or anywhere in the facility.
- No climbing up the slides on any of the inflatables.
- No sharp objects, please remove any objects that might puncture the inflatables.
- No wrestling or rough play.
- No jumping off of or on the inflatables.
- Only play with like ages and sizes on all inflatables.
- Do not go behind any of the inflatables and only enter from the entrance at the front of the inflatable.
- Do not sit, lean, or jump over or on the inflatable walls.
- No food, candy, gum, or drinks on the inflatables.

Egg Hunt Rules:

- Please let your children find the eggs themselves.
- Do not allow your child to take other kids' eggs.
- Do not allow your child to come into physical contact with any other child during the hunt. (Holding hands is the exception.)
- No fighting over eggs; the child who touches an egg first gets it.
- Be respectful and allow the kids to have fun!
